REQUEST TO STOP SUPPRESSING FREE SPEECH

Dear all,

We are writing to you to express both our concern and support for Dr. Frances Widdowson's right to hold a public lecture as scheduled for 18 January at the University of Alberta, on the subject of "Academic Freedom Under Threat". And to ensure that she can do so without harassment by anyone.

As citizens of Australia, we share a common heritage of academic freedom and rigour with Canada. Both our countries were known as "lucky countries", adhering to values of freedom of speech and expression, as is the basic foundation for civilised society.

Academia and education in general, at all levels, were never before as poisoned with politically enforced ideology as we've seen has become routinely done over the last several years.

Without the freedom to challenge popular views, no matter how fervently held, academic rigour cannot fully exist and the truth, therefore, cannot be fully discovered. Instead, the factual truth is being replaced with a feel-good, invented narrative, which often has nothing to do with true history.

Appalling practice of cancelling people – who dare to challenge some recently invented dogmas – such as Frances Widdowson, Jordan Peterson, Jim McMurthy, Paul Viminiz, Chanel Pfahl and others charged with "wrongthink" crimes is going to backfire in the long run.

A clear sign that Australians have had enough of this Orwellian political correctness with its communist-like "purges" was evident with the "Voice" referendum – held in Australia in October 2023 – when the majority of Australians finally said "Enough is enough!" and voted against further aboriginalisation of our country.

We expect the same change of heart would soon start happening in Canada. The issue of the right to conscience was dealt with by the United Nations Universal Declaration of Human Rights, Article 18, which stipulates that "Everyone has the right to freedom of thought, conscience and religion" as well as Article 19, which reads: "Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers."

² "The Aboriginal industry" is used as an umbrella term encompassing Aboriginal organisations, Government Departments and agencies, members of Parliament and judiciary who support and enforce aboriginalisation, as well as mainstream taxpayer-funded organisations and individuals who are compliant with the Wokeists' agenda.

Dear all,

we address this Open Letter to the Prime Minister Anthony Albanese, Senators and members of Parliament, as well as to all Australian people who have the best interest of our country at their hearts.

Our last Request to the Australian Government urged our then PM and the cabinet to stop the ongoing aboriginalisation of our country and to start listening to non-aboriginal Australians' concerns.

This Open Letter is our demand to start de-aboriginalisation of Australia, in which the first step of every patriotic Australian would be to vote No to the divisive and racist "Voice".

The reasons to vote No to the "Voice" as a way to say No to other issues ignored by the Wokeists were succinctly listed by Alexandra Marshall in her recent post:

"Australians should have said what they really thought of the Indigenous activist industry a long time ago. The corruption, abuse, and misuse of race for power ends NOW.

This isn't just #No to the #Voice. It's no to all of it.

No to 'Welcome to Country'. No to the renaming of our nation. No to racist national park lockouts. No to 'affirmative action' which disadvantages hard working citizens. No to handouts. No to sit-down money. No to separatism. No to giving criminals soft sentences because of their race. No to the bigotry of low expectations. No to the vandalisation of history. No to the whole grift."

To that list we need to add:

No to the Fakers – self-declared aborigines, also known as the box-tickers, whose numbers have skyrocketed over the last decade or so. Out of 984,000 "aborigines", it is assessed that hundreds of thousands are self-identifying fakers.

No to fake research, where the conclusions are set in advance, and the papers commissioned and their authors funded to engineer a way to reach already formulated, pre-set conclusion⁵.

No to corruption as is endemic in political and judiciary circles and Royal Commission Inquiry into Aboriginal Land Councils, as requested by Senator Jacinta Price.

No to hiding archaeological evidence and interfering with genetic research – it is well known that any genetic research of the "sacred" fossilised human remains is forbidden in Australia, not because it is "sacred" but because it shows to which race/species those remains actually belong.

Aboriginalisation of our country is out of control, escalating to incredible proportions.

Rather than curbing this trend of complying with all the insane demands as are being made by the taxpayer-funded aboriginal industry apparatchiks and Woke "activists", our Government now wants to bring us more misery, more division, and more hostilities by proposing the so-called Voice.

This brazen disregard for wellbeing of non-aboriginal Australians has pushed most of us beyond the breaking point. While some politicians are aware of the frustration and increasing anger of the majority, some – including our current PM – remain oblivious to what the non-aboriginal Australians think and feel.

We note that there are a number of great people fighting this seemingly un-winnable fight against snowballing destruction of our democracy, disintegration of our society, division and animosity that has never been seen in Australia before.

It is our right to now demand to be released from the shackles of Woke lunacy.

It would take too long to list all the facts and figures, such as that the aborigines were never the “first people” on our continent; that the whole First Nations concept and claim of 60,000 years of aboriginal presence were just made-up by dishonest academia, to provide ostensibly justifiable basis for making aborigines the most over-funded, over-privileged and pampered people in the world⁶.

So-called “decolonisation” was a bad idea – implemented by way of removing all the books that “offend” the tribes, allowing aboriginal violence and vandalism to go unabated, because they are “angry” and “provoked”. When reading now forbidden research results by our best prehistorians – such as John Mulvaney and Rhys Jones, and anthropologist Alan Thorne and researcher Grahame Walsh, as well as forbidden genome sequencing results by our geneticists Sheila van Holst Pellekaan and Greg Adcock (all of whom refused to alter their research results in order to please the aboriginal industry demands) we cannot think of any aboriginal achievements prior to 1788 that might justify for them being declared a special race, deserving of accolades over and above the rest of us.

Even the Max Planck Institute in Germany, and its Nobel Prize winning Director Svante Paabo – as well as with them associated universities and institutes in Europe and Asia – are being harassed for conducting research on ancient Australian aboriginal skeletal samples. By proving that Australian aborigines have the highest percentage – 6% – of Denisovan genes in their genome⁷, those scientists sent the aboriginal industry in overdrive, since their research results undermine the fake story about Australia’s prehistory.

What have the tribes contributed our society that would justify giving them special treatment over and above every other Australian? There is nothing their race has contributed to today’s society. It is still all about take-take-take without giving anything positive in return⁸.

Aboriginal “science” never existed. Aboriginal “art” is just a style taught to them in 1972 by white teacher Geoffrey Bardon, which the tribes appropriated just as they appropriate everything from our civilisation without ever either seeking permission or saying thank you.

The “Voice” is being spearheaded by the PM Anthony Albanese, already proven a liar, and by his favourite spokesperson and hard-core communist Thomas Mayo, who keeps glorifying his “communist comrades” and wants Australia shaped accordingly.

Or, more recently, Wakka Wakka elder Goomblar Wylo, who had his life destroyed by fake aborigines in the Blue Mountains, for telling the truth about aborigines today. Or Grahame King, who was among the first to fight for aboriginal rights back in the 1970s, only to be bitterly disappointed and publicly summed the situation up in 2010 by saying: “We have turned into toxic people, we poison everything we touch” – and was also attacked by the same Fakers and Woke public servants at the Blue Mountains City Council.
